You will be entitled to receive hard copies of the contract of deposit account, disclosures, statements and any account information by mail. To receive hard copies by mail you should contact the Customer Service Department Monday through Friday from 8:30 am to 4:30 pm by the phone number 939-337-8000. This request may be subject to a charge unless prohibited by law. Any applicable fees will be included in the disclosures of terms and deposit accounts held with BIB and use the electronic banking service conditions.
